GENERAL

INFORMATION

1. This event is governed by SOBHD Rules. The judge's decision is final.
2. Registration for BEGINNER and NOVICE dancers shall be at 8:30 a.m. with dancing to commence at 9:00 a.m. Intermediate and Premier dancers will compete following the lunch break. These dancers may opt to register at 8:30 a.m. or at 11 a.m. **NO dancer will be allowed to compete without a registration card in hand at registration time** per SOBHD rules and FUSTA enforcement.
3. Dancing will commence with all national dances. Challenge dances will be held following the standard competition dances. Medals will be awarded after each competition session (morning and afternoon).
4. All dancing events will be held on Saturday.
5. Passes will not be mailed. The ticket takers will have a list of all competing dancers and they will not be required to pay to enter the field.
6. Age groups will be determined prior to the competition based upon the numbers of dancers entered in each category.
7. First to enter shall be last to dance.
8. A late fee will be assessed for any entry RECEIVED after the closing date.
